Cascade Symphony seeks an exceptionally accomplished young musician to perform as soloist with Cascade Symphony at the

CHILDREN'S CONCERT - 3:00 PM - FEBRUARY 7, 2026

ELIGIBILITY: Piano or Violin - Applicant must be 12 years old or younger on the day of the concert, February 7, 2026. All Other Instruments - Applicant must be 15 years old or younger

on the day of the concert, February 7, 2026.

Previous years' applicants (except winners) may reapply as long as they still meet the age requirements.

APPLICATION FEE: \$40.00

AUDITION REQUIREMENTS: Applicants must submit a video recording of their performance uncut, unedited, and unaccompanied - of the piece specified for their instrument in the Rising Star Repertoire list (see page 2). The winner of the competition will perform the audition piece from memory with Cascade Symphony at the Children's concert on February 7, 2026.

RECORDING REQUIREMENTS: Applicants must record their video audition. **Begin by stating name, instrument, and piece performed.** Leave short pauses in place of extended rests. The use of high quality microphones is highly encouraged; the quality of the video is much less important.

UPLOAD: Upload your video to YouTube, using the Unlisted privacy setting.

APPLICATION: Complete the application form (page 3) and be certain to include the YouTube link to your video audition

DEADLINE: All materials must be mailed and uploaded by midnight, November 1, 2025.

NOTIFICATION: Finalists may be asked to audition in person. The winner and non-winners will be notified by letter by December 15, 2025.

AVAILABILITY: Winner must be available to rehearse with Cascade Symphony on Monday, February 2, 2026 and to perform on Saturday, February 7, 2026.

To audition, submit a recording of your performance - uncut, unedited, and unaccompanied - of the piece specified below for your instrument. Include cadenzas traditionally associated with your concerto. Wherever your part has a long rest, leave a short pause, then resume playing.

VIOLIN:

Mozart Concerto No. 3 in G major, K. 216 - 1st movement with cadenza

VIOLA:

JC Bach/Casadeseus, Concerto in C minor - 1st movement

CELLO:

Boccherini, Cello Concerto in B flat major, G. 482 - 1st movement

BASS:

Dragonetti Concerto - 1st movement

FLUTE:

Mozart - Concerto No. 1 in G, K. 313 - 1st movement

OBOE:

Mozart, Concerto in C, K. 314 - 1st movement

CLARINET:

Carl Maria von Weber, Concerto No.1, Op. 73 - 3rd movement

BASSOON:

Mozart, Concerto in B flat major, K. 191 - 1st movement

FRENCH HORN:

Mozart, Horn Concerto No. 3, K. 447 - 1st movement

TRUMPET:

Haydn, Concerto in E flat - 2nd and 3rd movements together

TROMBONE/ TUBA/ EUPHONIUM:

David, Concertino - 1st movement

PERCUSSION: Kreisler, Tambourin Chinois

HARP:

Handel, Concerto in B flat - 1st movement
